- A. The introduction needs to justify and articulate the focus and questions of this study from the relevant scholarship , policy , and practice perspectives using relevant literature as support . Researchers should develop research objectives at the end of the introduction in alignment with the study focus. *Continuing with the notion of halal, which has the literary meaning of permissibility in Islam, it revolves around the food and beverage industries , whereas haram exists to indicate the ban of specific things following Islamic values and Shariah standards....* needs more clarity
- B. The authors should explain Halal Food and Cybercrime separately. *To mitigate the risk associated with halal meat supply chains, collaboration among many partners is held, resulting*

*in the preservation of halal food integrity. Numerous additional parameters are included.....*

### **Comments to authors**

The detailed comments regarding each part of the manuscript are given as follows, which may be helpful to the authors in improving their paper.

- The start of the paper is good. However, too much detail in the introduction makes it boring and overworked. Rather than focusing on the gap and discussing the reason for proposing the model and justifying the proposed associations, the author/authors primarily did not focus on explaining Halal food. The detail of how this study can advance our knowledge in this area is missing. Moreover, the authors have not properly utilized to devise the research gap to make the manuscript more influential. The authors tried to present a gap, but the references are not updated.
- The literature review needs to be much more clearly written. The ideas are there, but they need to be explained further, and the ideas need to be more clearly linked together. An in-depth literature review is required to build a hypothesis and clearly understand the main concepts. There are many statements and claims, and paragraphs without references/citations. I must say there is a dire need to read the latest literature and support the arguments in hypothesis building.

- Results need to be more detailed, and authors should also report the descriptive statics in table and text form
