Only internal control and annual member meetings are analyzed.

In the explanation of the partial influence, there is a statement regarding women's cooperatives in the implementation have not implemented internal control to the fullest and have no influence on the financial performance of the women's organization. Why was it not mentioned before about women's organizations? Besides, why is it said to have no significant effect on financial performance? How do you see the significance?
7. The partial linear regression results of the effect of AMM on financial performance produce alpha 0.705, and this means that alpha higher than 0.05 has a significant effect. How can you conclude like this?
8. Conclusions do not match the results and discussion

Abstract— The purpose of this study is to analyze cooperative management in improving financial performance in East Java, Indonesia. Cooperative management in this study includes internal control, and the implementation of the annual member meeting (AMM). Financial performance is measured by a report on the calculation of cooperative operating results. Responsibility for collective management will be conveyed to AMM. AMM measurements are measured at the implementation of an annual member meeting. The research data uses secondary data in the form of financial reports and annual member meeting reports. The object of this study was 159 cooperatives in East Java, Indonesia. This study uses multiple regression analysis with SPSS. The results of internal control research have a significant influence on financial performance. The implementation of member meetings does not have a significant effect on financial performance.

Introduction

Cooperative organizations have specific characteristics compared to other organizations. Internal control

The linear regression results of internal control on financial performance produce alpha 0,000. This means that alpha less than 0.05 has a significant effect with a negative direction. This means that women's cooperatives that generate large profits internal supervision in cooperatives are still very weak,

whereas women cooperatives that have small profits have large internal controls. Cooperative supervision has not gone well. The cooperative's financial performance went well due to the hard work of the executive board.

Implementation of Member Meetings

Regression results show the annual member meeting on financial performance produces alpha 0.705, this means alpha is higher than 0.05, does not have a significant effect. Implementation of member meetings in carrying out cooperative operations must be carried out according to the rules. Cooperatives that experience large profits and small profits must carry out annual member meeting activities as a responsibility in cooperative management. The responsibility of the board to members is not only at the annual member meeting but continuously in the cooperative's operational activities. The AMM will be accounted for in the previous year's cooperative revenue budget plan. The AMM discusses work programs for the following year. The management must be transparent and responsible in running the cooperative's operations

The results of this study support the stakeholder theory. Stakeholders will benefit from corporate governance implementation that improves performance. Cooperatives that perform well will help members and the surrounding community. Cooperative members can feel the results by obtaining business capital with low interest — the population before the collective borrowed money from loan sharks. More broadly, the existence of cooperatives can reduce poverty and improve the economy of the community. This study supports [15], [16] describes that corporate governance has a vital role in performance, in particular the implementation of internal control and the implementation of annual member meetings as a function of accountability.

5. Conclusion

Profit or report on remaining operating results will increase with the active role of cooperative members. Business results reports will be reported at annual member meetings. In AMM, the remaining proceeds are distributed to members by the provisions. Cooperative members feel the benefits of profit sharing. Another advantage of cooperative members, borrowing money from a cooperative does not need to use asset guarantees.
