Three hundred seventeen students from five public vocational high schools in Surabaya, Indonesia, participated in this study. The research model is evaluated by structural equation modeling (SEM). The findings of this study indicate that entrepreneurial orientation and self-efficacy impact the entrepreneurial intentions of vocational high school students. Meanwhile, social capital did not impact students' entrepreneurial inclinations. Moreover, entrepreneurial self-efficacy influences the impacts of entrepreneurial attitude orientation and social capital on the entrepreneurial intents of students. The findings of this study have substantial significance for vocational education practitioners seeking to foster entrepreneurial aspirations among secondary vocational students. The topic of this research is interesting and relevant. The manuscript is overall well-structured. However, various areas need improvement, which is mentioned in the coming sections in detail.

The statement Self-efficacy also impacts a person's drive to plan an action needs a thorough explanation.
- ii. The literature review is very well elaborated, with the required details. Authors should build arguments on logical facts for the mediation hypothesis.
- iii. The methods section is written well. However, there is a need to elaborate on who was the population in this study. The table should be added presenting the demographic characteristics of the respondents. Authors are also encouraged to add details about the Measurement of variables with a separate heading.
- iv. The authors should discuss the validity and reliability of the questionnaire in detail, along with the presentation of the hypotheses results in tabular form.
- v. The discussion section is very brief. The findings linked with the fact that entrepreneurial self-efficacy increases the entrepreneurial intentions of vocational high school students need explanation.
- vi. The conclusion section should be added to summarize the fundamental research with significance/implications and recommendations.
