Decision: Major revisions required

This article, *Protection of Halal Product Guarantee for Muslim Consumers in Facing The ASEAN Economic Community (AEC)*, discusses the issue of protecting the halal product guarantee for Muslim consumers in the ASEAN Economic Community (AEC). The study uses a qualitative research design with a case-based approach and normative juridical approach to emphasize the use of written legal norms and the availability of halal food in Indonesia. The article highlights that halal certification has become mandatory in consumer protection because several countries have Muslim citizens, and it has become an important factor for a product to launch and sell in the AEC market. The study infers that the Indonesian halal industry tends to compete with even non-Muslim countries in distributing a halal-certified product. The study is a good addition to the existing body of literature. However, here are some suggestions.

- The article must present a clear introduction to the importance of the halal product guarantee for Muslim consumers, especially in Indonesia, and how halal certification has become

mandatory for consumer protection. The article should provide adequate information on the legal frameworks that support halal product guarantees in Indonesia.

- The article lacks a clear methodology section to describe the process of data collection and analysis. The study uses a qualitative research design, but it is not clear how the primary and secondary data were collected and analyzed. The article would benefit from a more detailed explanation of the research process to provide readers with a better understanding of the study's credibility.
 - The article could provide a more in-depth analysis of the impact of the ASEAN Qualification Recognition Framework (AQRF) on halal product guarantees for Muslim consumers in the AEC. Although the article mentions the AQRF in the keywords section, it does not provide any significant discussion of its impact on halal product guarantees.
 - Overall, the article provides valuable insights into the halal product guarantee for Muslim consumers in the AEC, but it would benefit from a more detailed explanation of the research methodology and a more in-depth analysis of the AQRF's impact.
 - The article needs proof editing with the help of professional proof editors.

Decision: Major revisions required

The paper is well-structured and provides relevant information on the topic. The sources used in the paper are up-to-date and reliable. However, it could be improved by providing more specific examples of the impact of halal certification on international trade, focusing on the following points.

1. The literature review provides a comprehensive discussion of the regulations and laws related to halal product guarantees, with a focus on Indonesia and ASEAN countries. However, the review should highlight the importance of ensuring halal-ness in the production chain and the role of Law Number 33 of 2014 concerning Halal Product Guarantee in providing legal certainty for consumers, producers, marketers, and retailers. The literature review also needs to touch on the Consumer Law that guarantees legal protection for consumers and their rights to obtain correct, clear, and honest information regarding the products' conditions.
2. Regarding halal certification, the study must discuss its importance in ensuring the quality of halal products in the free market, with a focus on ASEAN countries. The study should present the status of halal certification in the ASEAN countries and highlights the impact of halal certification in the international trade market.
3. In the methods section, the description of the data collection methods and sources of data needs clarity and detail.
4. The use of primary and secondary data is appropriate for this type of research. However, the analysis methods used must be elaborated in detail.
5. The discussion of the Law Number 33 of 2014 concerning the Halal Product Guarantee should be well-supported by relevant sources, and the authors should provide a clear understanding of the philosophical, sociological, juridical, psycho-political, and economic foundations of this law.
